

ORDINANCE NO. 2009- 11

ORDINANCE AMENDING CHAPTER 10.08 OF
THE CODIFIED ORDINANCE OF THE
TOWNSHIP OF OCEAN ENTITLED "PARKING"

BE IT ORDAINED by the Township Committee of the Township of Ocean, in the County of Ocean, State of New Jersey, as follows:

SECTION 1: Purpose. The Township of Ocean is the owner of property upon which sewer infrastructure facilities are located. These facilities must remain open for access at all times both for regular maintenance thereof and also for emergency situations. The Township Committee has been notified that at two of these locations, individuals are parking their personal motor vehicles on said property and/or in the driveways of these publicly owned lands, blocking access to sewer lift stations. The purpose of this Ordinance is to prohibit the parking of motor vehicles on said properties.

SECTION 2: Chapter 10.08.060 shall be amended to include therein an additional provision as follows:

No person shall park or permit the parking of a motor vehicle they may own or lease on the following Township owned properties:

- a. Block 240, Lot 11
- b. Block 85, Lot 2
- c.

SECTION 3: Penalty. Any person violating or failing to comply with the provisions of this Chapter shall, upon conviction thereof, be punishable by a fine of not less than \$100.00 nor more than \$250.00 as determined in the discretion of the Municipal Court Judge.

SECTION 4: If any section, subsection, sentence, clause, phrase, or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 5: This ordinance shall take effect after second reading and publication as required by law.

NOTICE IS HEREBY GIVEN that the foregoing Ordinance was introduced and passed by the Township Committee of the Township of Ocean on first reading at a meeting held on the 22nd day of October, 2009.
