Vince Anepete, 85 Clearwater Drive, recommended a part-time clerk at minimum wage to process OPRA requests and type minutes.

Mayor Lachawiec stated Mr. Anepete's recommendations are appreciated and will be taken under advisement.

Ed Covitz, Brookville, stated the Board of Health meetings are incorrect.

Deputy Mayor Tredy stated the Board of Health applied for use of the Community Center prior to having the Reorganization meeting. The actual dates will be published properly.

Township Attorney McGuckin stated the application should be resubmitted by the Board of Health with the correct dates.

Michele Rosen, 29 Bradley Beach Way, requested a copy of the report from Mr. McGuckin's office regarding OPRA costs.

Deputy Mayor Tredy requested Ms. Rosen fill out an OPRA request for the OPRA costs. There are some items that were not calculated, such as the costs from the construction office, the zoning office and the COAH.

Ms. Rosen stated the Township Committee has not approved executive session minutes, so Ms. Rosen OPRA'd them from 1999 to 2009. Prior to submitting OPRA requests to this township, the town did not have petty cash funds established or any restrictions on in-house or credit card accounts. Citizens have the right to see documents.

Harry Dering, 15 Dock Avenue, Ms. Rosen is costing the taxpayers a ton of money and she does not own property in this town. Stop causing the taxpayers unnecessary money and time, especially at the town meetings. Ms. Rosen is not a taxpayer in this town.

Tom Marquet, 95 Spring Lake Blvd., OPRA is pursuant to the statute. Whatever the costs are that is the cost of government and citizen participation.

Debra Battaglia, Morey Place Road, requested crushed concrete in the potholes on Morey Place Road. Scibal informed her the property is wetlands and there is restrictions. The only thing that could be put down is crushed concrete.

Committeeman Kraft stated Ms. Battaglia lives on a dirt road. Cars need to drive slowly down Morey Place Road. Driving fast causes rocks to get in the grooves of the tires. The town maintains the road once a month. Committeeman Kraft stated the developer has site plan approval and has to abide by the approval. The road is going to be where it was engineered to be. It will be a newer road.

Spencer Hondros, 65 Pennsylvania Avenue, inquired if Morey Place Road used to be a private road.

Deputy Mayor Tredy stated a resident used to take care of the road. It was not a private road.

Ralph Avellino, 10 Central Avenue, stated the Founder's Day Committee was confronted with its deficiencies at the reorganization meeting. Founder's Day activities are presented to and approved by the township Finance Officer. The township did not pay for anything for the day's events.

Mayor Lachawiec thanked Mr. Avellino and every member of the Founder's Day Committee for devoting their time all these years for the benefit of this town. It is appreciated and the town wants Founder's Day to continue. Other citizens in town do have the right to investigate. Mayor Lachawiec suggested the Celebratory Event line item, to be discussed for the budget, be \$40,000 to \$50,000. The Founder's Day fundraising should come into the town on a different line item.

Township Attorney McGuckin stated there is a dedicated trust fund account for Founder's Day. Township Attorney McGuckin will check with the auditor as to where donations should be placed. The Founder's Day Committee is supposed to develop and implement their plans for the funds and advise the governing body as to how it would occur. All the monies in the township account have been accounted for. Under a prior administration, Founder's Day was funded by the taxpayers, at approximately \$30,000. For the last 11-12 years, the taxpayers have not incurred this cost.

Deputy Mayor Tredy stated the Founder's Day Committee has done a fantastic job for years. They volunteer hours and hours. It is a shame people are trying to sabotage Founder's Day, due to minor procedural errors.

Spencer Hondros, 65 Pennsylvania Ave., is a Founder's Day Committee member and requested direction, at the next Founder's Day meeting, on how to proceed for Founder's Day 2010.

Mayor Lachawiec will address it.

Harry Dering, 15 Dock Avenue, anyone trying to destroy Founder's Day is out of order.

Vince Anepete, 85 Clearwater, Planning Board Chairman, investigated Morey Place Road. Anyone who drives more than 5-10 miles per hour is foolish.

Mr. An epete stated even though people may not agree, it is a persons right to speak. The town should listen to the message and defend the right to speak.
