PUBLIC COMMENT:

Motion to open to the public was moved by Committeeman Kraft, seconded by Deputy Mayor Tredy. Roll Call: Kraft: Yes, Tredy: Yes, Lachawiec: Yes

Ralph Avellino, 10 Central Avenue, stated he was a Dance Aide for many years and was never paid \$30 a night.

Mr. Avellino stated the Founder's Day Committee was crucified for having a raffle.

Mayor Lachawiec stated the matter is being investigated and will hopefully be resolved. Founder's Day raffles have nothing to do with the raffles on tonight's agenda. The town is looking at the legalities to ensure the Founder's Day activities occur. When the budget is presented, Mayor Lachawiec will ensure that there is a line item called Celebratory Events. The budget will have to be approved by the entire Township Committee.

Rocco Orlando, Brigantine Blvd., inquired about an emergency plan from the power plant a few months ago. Mayor Lachawiec stated he received an e-mail from the power plant. The Asbury Park Press reported that an emergency planning demonstration will take place January 28, 2010. Mr. Orlando spoke to David Benson, Plant Spokesman, who does not know anything about it. The County put the ad in the paper.

Mayor Lachawiec reported that Lt. Frenz of the Ocean Township Police Dept. stated the drill was going on at 6:30pm. The newspapers reported that there were some non-successes with various towns. The Township of Ocean had no faults or problems. It was some other town that did not get a follow-up fax after the telephone calls.

Rita Mygrant suggested Mr. Orlando contact the Ocean County Emergency Management Office.

Mayor Lachawiec will research the matter and call Mr. Orlando.

Jacqueline Petrosilli, 11 Vessel Road, stated there are two drills a year, held in the Office of Emergency Management at the State Police Headquarters.

Helen Henderson, Lanoka Harbor, American Littoral Society (ALS). ALS is a national coastal conservation group with over 10,000 members. ALS has participated in the Town Center Plan and various DEP issues. A Notice of Violation was issued by the DEP Enforcement Office to Coastal Redevelopment Urban Renewal Partners, who have not complied with numerous conditions on their CAFRA permit for development within the Town Center. These conditions have been continuing for a couple of years. Ms. Henderson was at the DEP reviewing the latest plans for Volunteer Way and requested the town's consultants sit with her and go over the mitigation plans and alternative analysis for Volunteer Way and upgrades to intersections along Route 9.

Mayor Lachawiec stated he is sure the town can accommodate Ms. Henderson's requests.

Township Attorney McGuckin stated some of those issues will be discussed in Executive Session this evening. After that, the consultant's will be in a position to advise Ms. Henderson.

Ms. Henderson stated other relocation sites for the solar project will run into similar problems, if they are in the CAFRA Zone or regulated by the Coastal Zone Management Rules. Solar panels are considered impervious cover.

Ms. Henderson would also like to discuss fertilizer restrictions in the new Town Center Development.

Deputy Mayor Tredy stated currently the Township's Environmental Commission is reviewing a fertilizer ordinance. An ordinance is anticipated.

Committeeman Kraft stated the town does not want to be restrictive. The town wants to be more educational on fertilizer. The Crystal Point site is a potential area, where the grant money would be used to plant native plants.

Ms. Henderson stated there is a list of native plant suppliers on the American Littoral Society website.

Mayor Lachawiec thought the Littoral Society and other conservationists would see the solar panels as a benefit.

Ms. Henderson stated energy conservation first. Alternative energy sources are the way to go.
