STATEMENT: Pursuant to the provisions of the New Jersey Open Public Meetings Act, adequate notice of this meeting was properly provided by sending copies of the Notice of Meeting to two newspapers, The Press of Atlantic City and the Asbury Park Press. The Notice was posted at the office of the Township Clerk and on the bulletin board in the Administration Building.

PUBLIC HEARING:

The Rehabilitation of the Route 532 Water Treatment Plant (WTP), that is to be funded by the NJDEP Environmental Infrastructure Trust Financing Program. The project location is the Route 532 water treatment plant located on Wells Mills Road. The estimated cost for the for the construction for the rehabilitation of the WTP is \$1,276,000,00

Wayne McVicar, Remington Vernick, Utilities Engineer, stated this is a loan to the New Jersey Environmental Infrastructure Trust Fund (NJEIT). This loan is 100% of the improvement, 50% at market rate. The reason for this hearing is the NJEIT determined this project is a level 2 environmental project. Public comment is pursuant to NJAC 7:22-10.10. The notice was placed 30 days in advance of this hearing. Once the hearing is over, there is a 30 day comment period, where members of the public can convey their comments to the Township Committee, Utilities Engineer or directly to the D.E.P. The planning documentation is available for the public to review. The project is located at the Water Treatment Plant on Route 532. This is a rehabilitation of the Water Treatment Plant, which is an expansion from 2 to 4 filters. It will be possible to take one of the filters down for maintenance purposes and the remaining 3 filters would still have the capacity to meet the needs of the township. The electrical system is also being upgraded. The improvements include the installation of a ten-foot filter adjacent to the existing ten-foot filter. The filter header will be removed on the two existing eight-foot-diameter filters and a new twelve-inch header piping will be installed to all four filters, install an automatic electronically-operated butterfly valve system on the filters with an automatic control system. The filters will be housed in an expanded water treatment plant building. There will be a covered walkway from the building to the existing backwash building. A new 10,000 gallon backwash recovery tank will be installed. A new contact tank will also be installed with modifications to the existing water treatment systems that exist. Monitoring will be provided for Ph, humidity, flow and pressure. There will be upgrades to the electrical system, power distribution system and site restoration. Total cost is \$1,276,000.

Major fundraisers have been \$34,500 for "Homes for our Troops", \$3,100 to The Childrens Hospital of Philadelphia and various Township of Ocean organizations in excess of \$18,000.

Eileen Doyle, 243 11th Street, inquired about her request for more trips to the Ocean County Mall on the Oceanride.

Mayor Lachawiec stated he is processing paperwork due by March 22, 2010 to obtain a Township bus. If a bus is granted, the town will be able to schedule its own trips and will not be dependent on Oceanride.

Ed Hamilton, 27 Belmar Blvd., the Governor and President do not have any money. The town should govern as if it does not have any money. The town should not spend money on anything the town does not need. Every time the town spends money to buy Open Space land, the taxes go up on the remaining land. Waretown is close to 40% open space. That is enough.

Mayor Lachawiec inquired if there is a sunset on open space tax.

Township Attorney McGuckin stated when the township introduced the open space tax, it was submitted to a public referendum and it passed. That public referendum provided for a time frame and automatic sunset provision of 10 years from implementation. If there is no new referendum, it will cease to exist. Next year the public will have the opportunity to determine if they want to continue or not.

Mayor Lachawiec stated the town is divided into three parts. The far eastern part is mostly on Barnegat Bay. The far western part is already open space. The middle part has the most activity, which includes the town center. The town is close to getting the Volunteer Way permits. The DEP is asking the town to give land up for mitigation purposes for allowing the road to go through. The town has given plenty of land already. The town is going to try to get a mitigation land bank started. If open space money buys 500 acres of land, that land will be used to mitigate some development in the middle part of the town.

Mr. Hamilton stated the reality is the town has to develop. Every year homes are needed. The homes have to go someplace. The nation and population is growing and people have to live someplace.

Mayor Lachawiec stated since the last census, the town has grown 40%. The Master Plan calls for a plateau of 12,000 people. The town would like to concentrate its growth within the Town Center.

Committeeman Kraft announced his resignation from the Township of Ocean Committee, effective immediately. It is in the best interest for himself, his family and the municipality. Committeeman Kraft stands with the Mayor and Deputy Mayor and has full faith they can carry on. Committeeman Kraft thanked the public for their support.

Mayor Lachawiec thanked Committeeman Kraft for his years of service.
