Eileen Doyle, 243 11th Street, thanked Mr. Lachawiec for sharing Ocean Ride's response stating due to financial constraints, the Dept. of Transportation will not be expanding the services. Ms. Doyle states the riders are not asking for an expansion of services. The riders just want a change in direction.

Mayor Lachawiec will resolve the matter by next meeting.

Vince Anepete, 85 Clearwater Drive, requested the Committee elaborate on the closed session Request for Proposals issue. Mr. Anepete also inquired if the Morey Place bond reduction had anything to do with the developer's requirements to provide proper lighting.

Mayor Lachawiec stated in January John Russo was approved as Township Affordable Housing Attorney. Mr. Russo had the honor of being appointed as an Administrative Law Judge and can no longer be a Township Attorney. A request for proposal went out. The two responses will be discussed in closed session.

Township Attorney McGuckin stated the Morey Place Road issue does not affect the lighting. It is a reduction of the performance bond for work the developer has done. It is part of the approved subdivision. The engineer is aware of the lighting issue and did not approve the reduction for that.

John Petrosilli, 11 Vessel Road, inquired if the town has funding in place to upgrade the water filtration system.

Township Attorney McGuckin stated the town is applying for the funding and has not received it yet. The work will not be completed without the funding in place. It is 50% grant and 50% low-interest loan. If the town can get the NJ Environmental Infrastructure Trust grant, that would be beneficial to the municipality due to the fact it is 50% grant and the other half would be borrowed.

Mayor Lachawiec stated whenever possible the township works in-house. At the water treatment plant on Route 532, the 2-B Filter needed repair on a small piece of piping that supports the drain system. The repair was quoted by an outside contractor for \$20,000. The township was also quoted \$60,000 per filter to replace the media. The broken pipe was repaired and the filter was replaced in-house. It will be tested for bacterial agents and anticipate having the filter back online by Monday morning. The Utilities Supervisor will provide a complete financial report on how much the town saved by doing the work in-house.
