

**ORDINANCE NO. 2010-4**

**ORDINANCE AMENDING CHAPTER 2.92 OF  
THE CODIFIED ORDINANCES OF THE  
TOWNSHIP OF OCEAN ENTITLED "SENIOR  
CITIZENS ADVISORY COMMITTEE"**

**BE IT ORDAINED** by the Township Committee of the Township of Ocean, in the County of Ocean, State of New Jersey, as follows:

**SECTION 1:** Purpose. The Township of Ocean has previously established a "Senior Citizens Advisory Committee" for the Township of Ocean which advisory committee consists of five (5) members appointed annually by the Township Committee. It is the intention of this ordinance to provide for two (2) alternate members to serve on said Senior Citizens Advisory Committee.

**SECTION 2:** Chapter 2.92.020 entitled "Membership-Term-Officers" shall be amended to include an additional provision as follows: In addition, the Township Committee may appoint not more than two (2) alternate members. One such alternate members shall be designated at the time of appointment as Alternate No. 1 and the second as Alternate No. 2. The terms of all alternate members shall be for one (1) year with all terms to expire on December 31 of the year of appointment. Alternate members may participate in discussions and proceedings but may not vote except in the absence or disqualification of a regular member. No alternate member may serve as chairperson or vice-chairperson. A vote shall not be delayed in order for a regular member to vote instead of an alternate member. In the event that a choice must be made as to which alternate member is to vote, Alternate No. 1 shall vote first.

**SECTION 3:** If any section, subsection, sentence, clause, phrase, or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 4:** This ordinance shall take effect after second reading and publication as required by law.
