

RESOLUTION 2010 – 278

**RESOLUTION AUTHORIZING REFUND OF
CERTAIN ZONING PERMIT, ELECTRICAL PERMIT
AND BUILDING PERMIT FEES PAID IN
CONJUNCTION WITH ON GROUND POOLS.**

WHEREAS, the Township of Ocean, County of Ocean, State of New Jersey, has received input from its citizens as to the permit fees required for the construction and location of an on ground pool; and

WHEREAS, the Township has been advised that the total cost of the permit fees exceed the value of the on ground pool, which has been defined in the Township code as pools with no greater depth of 36 inches; and

WHEREAS, the Township believes it appropriate and necessary to amend the current Township code in order to minimize the amount of fees and inspections required for on ground pools; and

WHEREAS, the Township believes it appropriate and necessary under the circumstances to remit to those homeowners and applicants who have paid in excess of \$50.00 for zoning, electrical and building permit fees, in conjunction with on ground pools; and

WHEREAS, the Township believes that a total fee of \$50.00 will adequately compensate the Township for all administrative and professional fees incurred with regard to the inspections of on ground pools.

NOW, THEREFORE BE IT RESOLVED this 20th day of August, 2010 by the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey as follows:

1. The Township authorizes and directs a remittance to all permit applicants for on ground pools who have paid in excess of \$50.00, in total, for zoning, electrical and building permits in conjunction with installation of on ground pools.
2. The Township authorizes and directs the Mayor, Township Clerk, Township Administrator and Certified Financial Officer to execute any and all necessary documents in order to implement the intent of this Resolution.
