A RESOLUTION AUTHORIZING THE SUBMISSION OF APPLICATIONS FOR FINANCING UNDER THE NEW JERSEY ENVIRONMENTAL INFRASTRUCTURE TRUST 2011 FINANCING PROGRAM FOR THE REHABILITATION OF TOWNSHIP WELL NO. 6 AT THE ROUTE 532 WATER TREATMENT PLANT

WHEREAS, the Township of Ocean, in the County of Ocean, intends to file applications with the New Jersey Department of Environmental Protection (“**DEP**”) and the New Jersey Environmental Infrastructure Trust (the “**Trust**”) for the financing of a drinking water project consisting of the rehabilitation of Well No. 6 at the Route 532 Water Treatment Plant, such project to be more particularly described in the applications (the “**Well No. 6 Project**”) under the 2011 New Jersey Environmental Infrastructure Trust Financing Program (the “**2011 NJEIF Program**”); and

WHEREAS, the Township Committee of the Township of Ocean believes that it is in the best interest of the Township to file the applications with DEP and the Trust for the financing of the Well No. 6 Project.

NOW, THEREFORE, BE IT RESOLVED, by the Committee of the Township of Ocean, Ocean County, New Jersey, as follows:

Section 1. That Joseph Lachawiec, Mayor, Christine Thorne, Chief Financial Officer of the Township, and David Breeden, Township Administrator, are each hereby authorized to act as the Authorized Representative to represent the Township of Ocean in all matters relating to the Well No. 6 Project undertaken pursuant to the above referenced 2011 NJEIF Program to be executed with the New Jersey Department of Environmental Protection and the New Jersey Environmental Infrastructure Trust. The Authorized Representative may be contacted at the Township of Ocean, 50 Railroad Avenue, Waretown, New Jersey 08758, Phone No. 609-693-3302.

Section 2. The Township hereby authorizes the Authorized Representative to file all applications as may be required for loans under the 2011 NJEIF Program and to execute and deliver all applications, documents, bonds, instruments, or closing certificates as may be required in connection with such loan program.

Section 3. This Resolution shall take effect immediately.
