

RESOLUTION 2010 - 344

WHEREAS, on Wednesday, December 8, 2010, pursuant to legal advertisements therefor, sealed bids were received for the rehabilitation and expansion of the Route #532 water treatment plant; and;

WHEREAS, after receipt and examination of said bids it was determined that the low bidder on said project was TKT Construction Co, Williamstown, New Jersey in the bid amount of \$1,235,400.00 for the base bid plus alternate #2 proposal; and

WHEREAS, it is deemed to be appropriate and in the best interests of the Township of Ocean to accept the low bid of TKT Construction Co. to perform this project;

NOW, THEREFORE, BE IT RESOLVED by the Township of Ocean, County of Ocean, State of New Jersey, as follows:

The Mayor and Clerk are hereby authorized to enter into a contract with TKT Construction Co., Williamstown, New Jersey, 08094, subject to availability of funds, and review and approval by NJEIT in accord with the provisions of the approval letter of Wayne R. McVicar, P.E., P.P., C.M.E., dated December 9, 2010, accepting its bid in the amount of \$1,235,400.00 for the rehabilitation and expansion of the Route 532 water treatment plant base bid plus alternate #2 in accord with the bid submitted and the terms thereof as set forth in bid specifications.

BE IT FURTHER RESOLVED that copies of this Resolution shall be made available to the Administrator, Director of Utilities, Engineer, Attorney, Auditor, NJEIT and TKT Construction Co., the successful bidder.
