Deputy Mayor Tredy stated Matt Ambrosio is attending this meeting at the Committee's request to explain the single-stream recycling.

Matt Ambrosio, Recycling Coordinator, stated the County is going to single-stream recycling, which means the product will be no longer separated. The object is to make recycling easier for the public. As of April 19, 2010, the County system has gone to single-stream recycling and the County is requiring every municipality to follow suit. All recyclables will be placed in one container and it will be dumped into one location on the truck. The first step is to educate the residents. The ACUA trucks are ready to accept single-stream. Currently there are two recycle cans: 1. Co-mingled, which is glass, aluminum, plastic 2. Fiber, which is cardboard, junk mail, newspapers.

Deputy Mayor Tredy requested Mr. Ambrosio prepare information on single-stream recycling for the next Township Committee meeting to inform the public.

Mr. Ambrosio will contact the surrounding municipalities and see how they are handling it.

Mayor Lachawiec inquired if the Townwide Clean Up Day is still going to be held in June.

Mr. Ambrosio stated yes.
