#### **Committee Reports**

#### Committeeman – Joseph Lachawiec

Resolution 2012-184 adopts the Floodplain Management Plan. The plan's objective is to produce a program of activities to tackle the community's vulnerability to hazards and meet other community needs. The Township participates in a community rating system, which can reduce flood insurance rates for all residents.

The NJ League of Municipalities is pressuring the state to return energy taxes to the towns. Energy taxes are franchise fees. As energy usage increased, the town's share increased. Support this resolution calling for the state to restore energy taxes to towns.

May 26, 2012 is Founder's Day. Events include the 3<sup>rd</sup> Annual Chili Cook Off, free children's rides, crafters, K-9 dog demonstration, tethered hot air balloons, living history and the annual Pet Parade. Opening ceremonies are 9:00am. The fireworks will be at the end of Bryant Road at dusk.

The Township Committee will deliver tonight a municipal budget that does not increase taxes or water/sewer rates.

#### Deputy Mayor - Tina Wetter

The Township Committee has been working closely with the Township Administrator and Chief Financial Officer to develop a budget that does not increase the tax burden but maintains quality municipal services to the community. For the third year in a row, the Township will introduce a budget that does not increase the municipal portion of the property taxes. The municipal tax levy is slightly less when compared to 2011. The Township was also successful in maintaining stable water/sewer rates even in light of the aggressive capital improvement program being undertaken by the Township to upgrade water/sewer infrastructure along with the backload of assumed debt from the now defunct Municipal Utility Authority that has caused a huge increase in debt service.

Running government is a team effort. By working together, the Township Committee is able to accomplish much that benefits all in Waretown. Deputy Mayor Wetter acknowledged the Township's employees and professionals committed to the well-being of the Township and thanked the residents of Waretown for having the faith and trust in the Township Committee to do what is best for the town. It is an honor and privilege to serve the residents of Waretown.

Residents can now view tax and utility bills on the Township's website and within 5-6 weeks residents will be able to pay tax and utility bills online.

# Mayor – Dennis F. Tredy

The 2012 budget reflects the commitment of realizing certain goals discussed at the Reorganization meeting on January 1<sup>st</sup>. Having an organization that is efficient, responds to the needs of the residents and is fair to its employees is important to Mayor Tredy, as an individual and as the Mayor of our community. Mayor Tredy takes pride in discussing the accomplishments of the Township's dedicated workforce including the Volunteers. The Township Committee has been successful in preparing another budget that does not increase the tax burden on the hardworking residents.

# **Administrator Report**

### Administrator - David Breeden

Ordinance 2012-4, Second Reading, Public Hearing, Bond Ordinance in the amount of \$1,850,000. This bond ordinance will fund water/sewer improvement work on three streets in the Skipper's Cove section of the community and will replace 4,300 feet of both sewer and water mains. This project will be financed through the Environmental Infrastructure Trust Fund and offers no-interest, low-interest loans and principal forgiveness.

Ordinance 2012-6, Second Reading, Public Hearing, Salary Ordinance, is a legal mechanism that allows the municipality to pay its employees.

Ordinance 2012-7, First Reading, CAP Ordinance, allows the municipality to exceed the municipal budget appropriation limits and is a finance mechanism offered by the state. If the municipality is under the appropriation CAP, the amount can be banked for future years. It has no impact on the tax rate or levy.

Ordinance 2012-8, First Reading, Bond Amendment, will fund work for the replacement of the Fire House roof in addition to facility improvement work and expansion at Town Hall. The existing bond ordinance use that has left over funding is being reallocating. This amended bond ordinance does not increase the overall debt of the Township.

Resolution 2012-156 authorizes the Township to seek approval of the Local Finance Board to participate in the New Jersey Environmental Infrastructure Trust program. This will fund the water/sewer work on Hornblower Drive, Bluebeard Way, and Hawkins Way.

Resolution 2012-159 authorizes the Township to go to permanent financing in the amount of \$916,000 for water/sewer work on Tuscarora Avenue that is ongoing.

Resolution 2012-160 approves a four-year agreement between the Township of Ocean and the PBA. The changes of the contract are that existing police officers pay 1.5% of their base salary as a health care contribution. The contract calls for a 2% salary increase plus a flat \$350.00 per year. Most of the salary increase will be offset by the health care contribution that will be given back by the Police Officer. Major concessions were made with new officers coming on board. The number of steps was increased from 7 to 10. The first and last steps of the longevity scale were eliminated. The Governing Body made a conscience decision respecting the dedication and commitment of the police force that existing officers would not be harmed. Both parties were satisfied with the outcome.

Resolution 2012-161 supports the establishment of a Regional Police Training Facility in Little Egg Harbor.

Resolution 2012-183 authorizes the execution of a shared services agreement with the City of Ocean City to share Public Works resources. The state is promoting and encouraging shared services and withholding state aid from municipalities who do not participate in meaningful shared services agreements.

Resolution 2012-184 adopts the Floodplain Management Plan. The Township of Ocean is in a floodplain zone. In order to be part of the national flood insurance program, the Township has to have a Floodplain Management Plan in place. Resident policy holders pay over \$1.2 million in premiums. Every 5% saved in residents' flood insurance premiums equates to \$63,000.

Mayor Tredy stated the Floodplain Management Plan was created by the hard work of Construction Official Ed Alvare, Zoning Officer Laurie Clune, Planning Board and Zoning Board Member John Petrosilli, Deputy Emergency Management Coordinator and Police Officer Scott Murphy and Engineer Ray Savacool of T&M Associates.

Township Administrator Breeden stated the Floodplain Management Plan program is very challenging to participate in. There are numerous requirements that are paperwork intensive but are well worth the effort to save considerable dollars in flood insurance premiums for the residents.

# - Budget Presentation

This is the third year in a row the Township of Ocean has been able to accomplish a budget that does not increase the financial burden of the residents of Ocean Township with respect to property taxes and/or water/sewer.

Municipal government is one of three entities that make payment of the tax bill. The County and School are the two other parties. Despite the economy, growth continued in Ocean Township. The amount of state aid in 2012 stayed the same at \$615,000. Tax appeals will not be an issue due to the 2011 reassessment. The Township has had a 98% tax collection rate since 2005. The Township sets aside a reserve for County and School taxes for people who do not pay their taxes.

The fund balance has been able to replenish and the Township is in a strong financial condition. The Township also has a high bond rating. The full-time workforce went down from 62 to 61 and the Township lost 9% of value as a result of the reassessment. The assessed value of the community is a little over \$1,243 billion.

The 2012 budget is \$10,751,819.00, which is a \$715,000 increase compared to last year. The one-time increase in debt service is in excess of \$500,000, which contributed to the majority of the 7.1% increase. There will be no tax increase for Ocean Township 2012 regarding municipal operations. The tax levy went down by \$3,000.

Township Administrator Breeden thanked the Township Committee for having the trust and faith in the Professionals who crafted this budget.

#### **PUBLIC PORTION:**

Dave Sharp, 29 Belmar Blvd., discussed Agenda 21, which states "government grant, restricts, or withdraws your rights according to its needs. You and the product of your labor belong to the community". Agenda 21 has a philosophy of energy conservation and sustainable development. Mr. Sharp requested the Township Committee pass a resolution in opposition of Agenda 21. Three counties have abandoned Agenda 21, Morris County, Somerset County and Ocean County.

Mr. Sharp also discussed the Foreclosure Transformation Act that forces municipalities to purchase foreclosed properties and dedicate them to affordable housing without normal planning, zoning or public input process.

Mayor Lachawiec inquired if Mr. Sharp's philosophy is opposed to towns participating in condemnation procedures for the good of the town.

Mr. Sharp stated that is how it should happen. It should not happen as a mandate from the federal government or the state.

Mayor Tredy intends to inquire on the State Assembly's position on this Foreclosure Relief Act. There is a lot of opposition to it but there are also organizations such as the State Realtors Association who say this is good. Mayor Tredy will look into the matter.

Eileen Doyle, 243 11<sup>th</sup> Street, complimented the library on their program called Liberty Bells about immigration.

Ms. Doyle reminded the Township Committee that the front door to the Community Center still sticks.

Township Clerk Ambrosio stated the contractor is not finished repairing it.

Ralph Avellino, 10 Central Avenue, thanked the Township Committee for keeping the tax rate the same but stated the taxes went up per hundred.

Township Administrator Breeden stated the taxes went up per hundred, however the value of the town decreased. Review the tax levy and how many dollars the town is requiring from the public to fund the municipal operation. In 2011 the Township needed \$5,767,499. In 2012 the Township needs \$5,767,234. The levy went down.

Mr. Avellino stated he is paying the same taxes on a house that is worth \$20,000 less. Do not say the taxes remained the same.

Township Attorney McGuckin stated the residents are paying more per hundred but the same amount in the year. The number of hundreds in the town is a lot less than it was last year.

Mr. Avellino stated for the last three years the Township has funded Founder's Day. Before that the Founder's Day Committee funded the event, including the Police Department.

Stan Anderson, 208 Maplewood Road, inquired the final tax rate.

Township Administrator Breeden stated the Municipal is .464, which may change by one tenth of a cent in either direction.
