

RESOLUTION 2012 -169

WHEREAS, an emergent condition has arisen with respect to the 2012 Temporary Operating Budget and no adequate provision has been made in the 2012 temporary appropriations for the aforesaid purpose, and NJS 40A:4-20 provides for the creation of an emergency temporary appropriation for the purpose mentioned, and

WHEREAS, the total emergency temporary resolutions adopted in the year 2012 pursuant to the provisions of Chapter 96,P.L.1951(NJS 40:4-20) including this resolution is \$3,474,503.87.

NOW, THEREFORE BE IT RESOLVED (not less than two-thirds of all the members therefore affirmatively concurring) that in accordance with the provision of. 40A:4-20:
