WHEREAS, the TOWNSHIP OF OCEAN wishes to provide a fireworks display on May 26, 2012 with a rain date of May 27, 2012; and

WHEREAS, the TOWNSHIP OF OCEAN has received a Contract Proposal from Pyrotecnico, P.O. Box 149, New Castle PA, Pa. in the amount of \$10,000.00 for Fireworks Display for May 26, 2012 with a rain date of May 27, 2012; and

NOW, THEREFORE, BE IT RESOLVED by the MAYOR and TOWNSHIP COMMITTEE of the TOWNSHIP OF OCEAN, as follows: the Township Committee of the Township of Ocean have authorized the above company to ignite fireworks within the Township of Ocean from a barge in the Barnegat Bay, events will be held at the end of Bryant Road at the Township Gazebo for the Township of Ocean's Founder's Day festivities the fireworks are scheduled for dusk on May 26, 2012 or on the rain date of May 27, 2012; and

BE IT FURTHER RESOLVED that a copy of the Declaration page for insurance be attached together with a copy of the Contract; and

BE IT FURTHER RESOLVED, the Chief of Police/Officer in Charge and Fire Department shall conduct an inspection the day of the fireworks display to ensure the display will not be a hazard to property or endanger any person or persons; and

WHEREAS, the proposed type/kinds of fireworks to be obtained of igniting the fireworks; and

WHEREAS, Schaefer Fireworks, Inc. or its designee, shall be in charge of igniting the fireworks; and

WHEREAS, storage of the fireworks prior to the display shall be subject to the approval of the Chief of the Fire Department; and

WHEREAS, any and all permits required, are to be provided by the company providing the Fireworks Display to the Township; and
