

Ordinance # 2012 - 12

An Ordinance of the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey, Amending Ordinance 2011-15 regarding Pawn Shops.

Be it ordained by the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey as follows:

SECTION I.

The Township of Ocean adopted Ordinance 2011-15 regulating second hand dealers such as pawn shops and requiring certain licensing requirements. The purpose of this Ordinance is to amend Ordinance 2011-15 to address comments and concerns raised subsequent to the adoption of Ordinance 2011-15.

SECTION II.

Ordinance 2011-15 shall be amended as follows:

Section I, Paragraph A delete "collectibles" and "bric-a-brac".

Section IV delete "collectibles" and "bric-a-brac".

A new sentence shall be added to the first Paragraph of Section IV immediately after "...within 24 hours", and immediately preceding the term "A licensee shall complete"... which shall state as follows:

A licensee shall photograph the items obtained along with the identification of the individual selling said items and forward that information electronically to the Ocean Township Police Department within 24 hours.

Section IV, Paragraph C, shall be deleted in its entirety.

Section IV, Paragraph H, shall be deleted in its entirety.

The remaining paragraphs shall be re-designated as follows:

Paragraph D shall now be Paragraph C;

Paragraph E shall now be Paragraph D;

Paragraph F shall now be Paragraph E;

Paragraph G shall now be Paragraph F.

Section V, Paragraph A shall be amended to include a new phrase at the beginning of said section which shall state as follows:

With the exception of coins, silver and gold bullion, which must be retained for a minimum of three (3) days, no licensee shall sell, alter or dispose...(no change to the balance of the first sentence)

Section VII shall be deleted in its entirety.

SECTION III.

This Ordinance shall take affect at the second reading and publication as may be required by law.

NOTICE IS HEREBY GIVEN that the foregoing Ordinance was introduced and passed by the Township Committee of the Township of Ocean on first reading at a meeting held on the 14th day of June, 2012. The Ordinance will be considered for second and final reading at a meeting of the Township Committee which is scheduled for the 12th day of JULY, 2012, at 6:30 p.m., or as soon thereafter as the matter may be reached, at the Municipal Building located at 50

Railroad Avenue, Waretown, New Jersey, at which time the public is invited to ask questions, raise objections, or provide public comment with regard to the proposed adoption of this Ordinance.
