**RESOLUTION AUTHORIZING THE AWARD OF A
CONTRACT TO EARLE ASPHALT COMPANY FOR
FY 2013 NJDOT MUNICIPAL AID ROAD
PROGRAM, CALDWELL ROAD IMPROVEMENTS.**

WHEREAS, the Township of Ocean has previously advertised for and received bids with respect to the project known as the "FY 2013 NJDOT Municipal Aid Road Program – Improvements to Caldwell Road"; and

WHEREAS, the Township of Ocean did receive bids for this project on October 8, 2013.; and

WHEREAS, the following bids were submitted, Earle Asphalt Company, \$147,713.13; Glenside Equipment Co., Inc., \$158,800; Johnson Baran Corp., \$149,367.17; and

WHEREAS, it appears that the lowest bid received for this project was from Earle Asphalt Company; and

WHEREAS, it appears that the lowest bidder has submitted all required information as outlined in the advertisement for receipt of bids and the bids specification; and

WHEREAS, by letter dated October 8, 2013, the Township Engineer has recommended to the Township Committee that the Township award a contract to Earle Asphalt Company as the lowest responsible bidder for the project; and

WHEREAS, the Township Committee wishes to accept the recommendation of its Consulting Engineer.

NOW THEREFORE BE IT RESOLVED this 9th day of October, 2013 by the Township Committee, Township of Ocean, County of Ocean and State of New Jersey as follows:

1. The Township hereby awards a contract to Earle Asphalt Company, Farmingdale, New Jersey, for the FY 2013 NJDOT Municipal Aid Road Program, Improvements to Caldwell Road in the amount of \$147,713.13 in accordance with the bid submitted on October 8, 2013.
2. That the Mayor and Township Clerk be and are hereby authorized to execute any and all necessary Contracts in order to implement the intent of this Resolution.
