

RESOLUTION 2013 - 308

**RESOLUTION AUTHORIZING CHANGE ORDER NO. 2
AND FINAL PROJECT CLOSEOUT NJDOT 2011 ROAD
PROGRAM**

WHEREAS, the Township of Ocean has previously entered into a Contract with Earle Asphalt Co., pursuant to the NJDOT Transportation Trust Fund 2011 Road Program; and

WHEREAS, the Township Engineer, James M. Oris, P.E., has recommended to the Township Committee, by way of correspondence dated November 1, 2013, that a Change Order be executed and authorized for this project which would adjust the contract quantities and result in a decrease from the adjusted contract amount from Change Order No. 1 of \$165,734.68 to a final cost of \$165,376.52; and

WHEREAS, the basis for this reduction of the Contract price in Change Order No.2 is due to revisions to restoration work based upon as built quantities, resulting in a reduction of \$358.16; and

WHEREAS, the Township Committee wishes to accept the recommendation of its Engineer and authorize Change Order No. 2;

NOW, THEREFORE BE IT RESOLVED this 14th day of November, 2013 by the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey as follows:

1. The Township hereby authorizes the execution of Change Order No. 2 which results in a final adjusted contract price of \$165,376.52 to be paid to Earle Asphalt, Co.
2. The Township Committee hereby authorizes Payment Certificate No. 3 in the amount of \$37,227.78 in support of final payment to the Contractor.
3. The two-year maintenance Bond shall remain in effect for this project.
