WHEREAS, pursuant to Resolution 2014-96, the Township Committee has previously authorized a receipt of bids for same; and

WHEREAS, bids were noticed and received on Wednesday, January 29, 2014 at 11:00 a.m.; and

WHEREAS, one bid was received from Bay Head Investments, Inc. in the amount of \$175,221.00 for a 2014 E-450 ELT Emergency Medical Vehicle pursuant to the bid specifications; and

WHEREAS, no other bids were received; and

WHEREAS, said bid was for a total price of \$175,221.00; and

WHEREAS, the Township of Ocean wishes to trade in its existing 1996 Ford E-350 PL Custom Type 3 Ambulance with approximately 106,600 miles; and

WHEREAS, said bidder had agreed to a trade-in value in the amount of \$3,000.00 resulting in a total net amount due under the proposed contract in the amount of \$172,221.00; and

WHEREAS, said bidder also included within its bid an optional item for a "Panasonic Tuff Book CF19 10.1 Series with pedestal, pole and adapter plate for an additional sum of \$7,500.00; and

WHEREAS, the sole bid received included all appropriate bid requirements as set forth in the bid specifications; and

WHEREAS, the Township Committee wishes to accept the bid of Bay Head Investments, Inc.
