

RESOLUTION 2014 - 145

RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH BARNEGAT TOWNSHIP FOR THE COLLECTION OF MONIES DUE TO OCEAN TOWNSHIP FOR PROVIDING WATER AND SEWER SERVICES IN BARNEGAT TOWNSHIP

WHEREAS, Ocean Township has and continues to provide water and sewer services (hereinafter the "System") to certain users in Barnegat Township; and

WHEREAS, Ocean Township is desirous to enter into an agreement, whereby Barnegat Township will ensure that delinquent Barnegat Township users serviced by Ocean Township's System will be listed for Tax Sale in Barnegat Township to protect Ocean Township's interests in receiving the monies owed for the services provided;

WHEREAS, Ocean Township has determined that it is in the best interest of the Township to enter into an agreement for the purposes of the facilitating past and future water and sewer service by Ocean Township to Barnegat Township residents;

NOW, THEREFORE BE IT RESOLVED this 24th day of April, 2014 by the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey as follows

1. That the Mayor and Township Clerk be and are hereby authorized to execute an agreement with Barnegat Township, whereby Barnegat Township will assist Ocean Township in collecting monies due to Ocean Township from Barnegat Township Residents for services provided by Ocean Township and its System; and
