

RESOLUTION 2014 - 196

RESOLUTION AUTHORIZING THE RELEASE
OF PERFORMANCE GUARANTEE FOR
GREENBRIAR OCEANAIRE, SECTION 7,
PHASE B - WATER SYSTEM IMPROVEMENTS

WHEREAS, Lennar Corporation is currently developing an age restricted residential community within the Township of Ocean known as Greenbriar Oceanaire; and

WHEREAS, in accordance with the approvals previously received for this project, the applicant has posted certain Performance Guarantees for various phases of said improvements; and

WHEREAS, the applicant has previously posted said Performance Guarantee for Section 7, Phase B - Water System Improvements; and

WHEREAS, the original Performance Guarantee was in the amount of \$350,647.02, which sum was later reduced to \$105,200.00 based upon completion of certain portions of the improvements; and

WHEREAS, the Township is currently holding a Performance Guarantee, Bond # SU11006903 issued by Arch Insurance Company dated September 11, 2012 in the amount of \$94,680.00 and a Cash Bond in the amount of \$10,520.00; and

WHEREAS, by letter dated April 3, 2014 the Township's Engineer has advised the Township Committee that they have inspected the improvements for this portion of the project and found same to be installed within substantial conformance with the approved subdivision plans and Planning Board approvals; and

WHEREAS, the Township Engineer has further recommended that said Performance Guarantee be released subject to certain conditions; and

WHEREAS, the Township Committee wishes to accept the recommendation of its Consulting Engineer.

NOW, THEREFORE BE IT RESOLVED this ____ day of _____, 2014 by the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey hereby authorizes the release of Performance Bond #SU1106903 issued by Arch Insurance Company dated September 11, 2012 in the amount of \$94,680.00 as well as the release of a Cash Bond currently being held by the Township in the amount of \$10,520.00 conditioned upon the following:
