

ORDINANCE NO. 2014 – 8

**AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF
THE TOWNSHIP OF OCEAN, COUNTY OF OCEAN,
STATE OF NEW JERSEY, AMENDING CHAPTER 61 OF
THE CODIFIED ORDINANCES OF THE TOWNSHIP OF
OCEAN**

BE IT ORDAINED by the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey as follows:

SECTION I.

Chapter 61-6 entitled “Appropriate Authority to Have Jurisdiction” shall be amended to include a new provision thereof to be designated as Subsection H:

- H.** Since the Police Department falls under the jurisdiction of the Chairman of the Township Public Safety Committee which is the “appropriate authority” for the promulgation, adoption, updating, and/or ratification of Rules and Regulations for the Police Department and its personnel, and since each of the following are designed to implement policies and procedures governing the Police Department, any and all General Orders, Operations Orders, Personnel Orders, Rules and Regulations and Standard Operating Procedures as defined in Chapter 3:8, et seq., of the Police Department Rules and Regulations, must be approved by the appropriate authority, in writing before taking effect. In addition thereto, the approval of the appropriate authority shall be required for any specialized duty assignments for any member of the Ocean Township Police Department. In addition before any member of the Department may register or be scheduled to attend any training session or course outside of the territorial jurisdiction of Ocean Township, same must be approved by the appropriate authority.

SECTION II.

Any section, subsection, clause, phrase, ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION III.

This Ordinance shall take affect after second reading and publication as required by law.

NOTICE IS HEREBY GIVEN that the foregoing Ordinance was introduced and passed by the Township Committee of the Township of Ocean on first reading at a meeting held on the 11th day of September, 2014. The Ordinance will be considered for second and final reading at a meeting of the Township Committee which is scheduled for the 9th day of October, 2014, at 6:30 p.m., or as soon thereafter as the matter may be reached, at the Municipal Building located at 50 Railroad Avenue, Waretown, New Jersey, at which time the public is invited to ask questions, raise objections, or provide public comment with regard to the proposed adoption of this Ordinance.
