RESOLUTION ACCEPTING A BID AND AUTHORIZING A CONTRACT WITH ROBERT H. HOOVER & SONS, INC. FOR ONE (1) 2015 4700SF DUMP TRUCK.

WHEREAS, the Township of Ocean has previously advertised for the receipt of bids for a new 2015 Dump Truck; and

WHEREAS, detailed specifications were available on the Township's Website in the office of the Township Clerk; and

WHEREAS, the time for submittal of all bids was Wednesday, October 22, 2014 at 11:00 a.m.; and

WHEREAS, one (1) bid was received in accordance with this proposal from Robert H. Hoover and Sons, Inc. of Flanders, New Jersey; and

WHEREAS, said bid included a 2015 Western Star 4700 or newer Dump Truck per the bid specifications in the amount of \$154,339.00, with a Duraclass dump body, snow plow and spreader; and

WHEREAS, in addition, the bid included three (3) warranty options as follows:

- 1) 5 year 100,000 mile Cummins engine warranty to include turbo and injectors and ATD (\$3,200.00);
- 2) 5 year Allison transmission warranty (\$546.00); or
- 3) 5 year towing and roadside assistance warranty (\$800.00).

WHEREAS, the sole bidder did not take any exceptions to the specifications; and

WHEREAS, it appears the bidder has submitted all appropriate documentation as required by the bid specifications and advertisement; and

NOW THEREFORE BE IT RESOLVED this 5th day of November, 2014 by the Township Committee, Township of Ocean, County of Ocean and State of New Jersey as follows:

1. The Township of Ocean hereby accepts the bid of Robert H. Hoover & Sons, Inc. in the amount of \$154,339.00 for one (1) 2015 Western Star 4700 Model Dump Truck, with snow plow, spreader and 100,000 mile warranty; and

2. The Township of Ocean also accepts the options set forth below:

- 1) 5 year 100,000 mile Cummins engine warranty to include turbo and injectors and ATD (\$3,200.00);
- 2) 5 year Allison transmission warranty (\$546.00); or
- 3) 5 year towing and roadside assistance warranty (\$800.00),

which will be added to the bid price of \$154,339.00.

BE IT FURTHER RESOLVED by the Township Committee, Township of Ocean, County of Ocean and State of Jersey that the Contract be awarded to Robert H. Hoover & Sons, Inc. in accordance with the terms and conditions as set forth in this Resolution, as well as the terms and conditions set forth in all specifications and advertisement, all of which are incorporated herein; and
