RESOLUTION ACCEPTING A PROPOSAL FOR EMERGENCY MEDICAL SERVICES, RESPONSE AND TRANSPORTATION SYSTEM FOR THE TOWNSHIP OF OCEAN AND THE TOWNSHIP OF BARNEGAT

WHEREAS, the Township of Ocean and the Township of Barnegat have previously advertised for the receipt of bids for the provision of basic life support emergency medical services, response and transportation in accordance with bid specifications duly advertised; and

WHEREAS, said proposals were provided on January 15, 2015; and

WHEREAS, three (3) proposals were received as follows:

- 1.) Monoc;
- 2.) Alert Ambulance; and
- 3.) ProCare.

WHEREAS, the Township Committee has been designated as the "lead agency" for purposes of this shared services agreement, and as a result thereof the Township Committee of the Township of Ocean conducted interviews with the prospective providers; and

WHEREAS, the Township Committee's primary concern is the health, safety and well-being of its residents, and those of Barnegat Township, who will share in these services; and

WHEREAS, the Township Committee finds each of the three (3) providers are capable of providing the service, however, it must choose one of the three vendors; and

WHEREAS, having considered the matter, the Township Committee of the Township of Ocean has determined to award the proposal to ProCare Ambulance Services conditioned upon the following:

- 1.) ProCare shall ensure that at least one (1) unit is located in Ocean Township and that at least two (2) are located in Barnegat Township;
- 2.) ProCare shall enter into a rental agreement for the use of a facility in Barnegat Township currently owned by the Municipality.

NOW THEREFORE BE IT RESOLVED this _____ day of _____, 2015 by the Township Committee, Township of Ocean, County of Ocean and State of New Jersey as follows:

1. The Township hereby accepts the proposal for ProCare Ambulance Services to provide basic life support and emergency medical services, response and transportation system in accordance with the proposal submitted on January 15, 2015 and in accordance with the conditions set forth hereinabove to ProCare Ambulance Services for a period of three (3) years effective April 1, 2015, expiring March 31, 2018.
