

**RESOLUTION NO. 2015 - 258**

**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF OCEAN, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE ADJUSTMENT TO THE TOWNSHIP'S BID THRESHOLD PURSUANT TO THE LOCAL PUBLIC CONTRACTS LAW**

**WHEREAS**, the Local Public Contracts Law, N.J.S.A. 40A:11-3(c), permits the Governor to exercise his authority to adjust the bid threshold for awarding contracts; and

**WHEREAS**, on July 1, 2015, the Governor increased the bid threshold for municipalities with a Qualified Purchasing Agent to \$40,000.00; and

**WHEREAS**, Mary Blood serves as the Qualified Purchasing Agent for the Township of Ocean.

**NOW, THEREFORE, BE IT RESOLVED**, this 30th day of July, 2015, by the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey, as follows:

1. That the Township Committee of the Township of Ocean hereby increases the bid threshold to \$40,000.00.

2. That the quotation threshold is also increased to \$6,000.00.

3. The Township authorizes and directs the Mayor, Township Clerk, and Township Administrator to execute any and all necessary documents in order to implement the intent of this resolution.
