**RESOLUTION AUTHORIZING THE TERMINATION OF A CERTAIN INTERLOCAL SHARED SERVICES AGREEMENT WITH BARNEGAT TOWNSHIP FOR THE PURPOSE OF SHARING AN ADMINISTRATOR AND APPOINTING AN ACTING ADMINISTRATOR FOR THE BALANCE OF CALENDAR YEAR 2015**

**WHEREAS**, the Township of Ocean and the Township of Barnegat entered into a certain Interlocal Shared Services Agreement dated February 8, 2012; and

**WHEREAS**, the Township of Ocean was authorized to enter into the Agreement by Resolution 2012-108; and

**WHEREAS**, pursuant to Section Six of the Agreement either party could terminate the Agreement for any reason; and

**WHEREAS**, the Committee of the Township of Ocean is desirous of terminating the Agreement; and

**WHEREAS**, the Township Committee of the Township of Ocean wishes to appoint an acting Administrator for the balance of calendar year 2015.

**NOW THEREFORE BE IT RESOLVED** this 8<sup>th</sup> day of October, 2015 by the Township Committee, Township of Ocean, County of Ocean and State of New Jersey as follows:

1. The Township hereby terminates the Interlocal Shared Services Agreement dated February 8, 2012 between the Township of Ocean and the Township of Barnegat, effective September 21, 2015.
2. The Township hereby appoints Diane Ambrosio as Acting Administrator for the Township of Ocean for the balance of calendar year 2015 at the rate of \$250.00 per week.

**BE IT FURTHER RESOLVED** that the Township Clerk, Mayor and any and all appropriate Township Officials are hereby authorized to sign any document and to take any and all other action necessary to effectuate the purpose and intent of this Resolution; and

**BE IT FURTHER RESOLVED** that a copy of this Resolution be forwarded to the appropriate official or officials in Barnegat Township and Ocean Township; and
