**RESOLUTION AUTHORIZING CHANGE ORDER NO. 2  
SKIPPERS COVE WATER MAIN REPLACEMENT**

**WHEREAS**, the Township of Ocean has previously entered into a contract with P&A Construction, Inc. for the project known as the "Skippers Cove, Seneca Boulevard and 11<sup>th</sup> Street Water and Sewer Main Replacement"; and

**WHEREAS**, in accordance with that contract, the contractor has requested a Change Order No. 2 for the potable water provisions of said contract; and

**WHEREAS**, by letter dated October 6, 2015 the Township Engineer, James M. Oris, P.E. has recommended to the Township Committee that Change Order No. 2 be executed for the water main replacement portion of this contract for extra work for the relocation of four (4) water services on Seneca Boulevard and the installation of additional gate valve on 11<sup>th</sup> Street; and

**WHEREAS**, this Change Order would increase the previously adjusted contract amount from \$1,726,864.44 to \$1,741,183.83 which would represent an overall increase of 0.333% of the contract amount; and

**WHEREAS**, the Township Engineer has advised the Township Committee that these costs are eligible under the current project funding through the NJEIT; and

**WHEREAS**, the Township Committee wishes to accept the recommendation of its consulting engineer.

**NOW THEREFORE BE IT RESOLVED** this 12<sup>th</sup> day of November, 2015 by the Township Committee, Township of Ocean, County of Ocean and State of New Jersey as follows:

1. The Township of Ocean hereby authorizes Change Order No. 2 for the potable water contract between the Township of Ocean and P&A Construction in accordance with the information set forth in this Resolution.
