

**RESOLUTION AUTHORIZING CHANGE ORDER NO. 2
POTABLE WATER CONTRACT WITH P&A
CONSTRUCTION, SKIPPERS COVE, SENECA
BOULEVARD AND 11TH STREET WATER AND SEWER
MAIN REPLACEMENT**

WHEREAS, the Township of Ocean has previously entered into a contract with P&A Construction, Inc. for the provision of Water and Sewer Main Replacements within Skippers Cove, Seneca Boulevard and 11th Street; and

WHEREAS, the previously adjusted Contract totaled \$1,726.864.44; and

WHEREAS, by letter dated November 4, 2015 the Township Engineer, James M. Oris, P.E. has recommended to the Township Committee that the Township authorize Change Order No. 2 to said Contract which would result in increase in the adjusted Contract amount to \$1,729,066.87 for an increase of 0.128%; and

WHEREAS, the Township Committee wishes to accept the recommendation of its consulting engineer.

WHEREAS, said increase results from extra work for the relocation of four water services on Seneca Boulevard and the installation of additional gate valves on 11th Street; and

WHEREAS, these costs are eligible for project funding through the New Jersey Environmental Infrastructure Trust which is assisting in the funding of this project.

NOW THEREFORE BE IT RESOLVED this 12th day of November, 2015 by the Township Committee, Township of Ocean, County of Ocean and State of New Jersey as follows:

1. The Township of Ocean hereby authorizes Change Order No. 2 for the Skippers Cove, Seneca Boulevard and 11th Street water and sewer main replacements specifically the Potable Water Contract with P&A Construction increasing said Contract to the amount of \$1,729.066.87.
