

**RESOLUTION REJECTING BIDS FOR THE TOWNSHIP'S  
BARRIER FREE ACCESS IMPROVEMENTS FOR THE  
MUNICIPAL COMPLEX**

**WHEREAS**, the Township of Ocean has previously advertized for the receipt of bids for the project known as "Barrier Free Access Improvements at the Municipal Complex"; and

**WHEREAS**, two bids were received for this project including as follows:

1. J.H. Williams Enterprises           \$68,000.16
2. Cypreco Industries, Inc.           \$567,400.30, and

**WHEREAS**, the bids received far exceed the Township estimate for the work to be performed; and

**WHEREAS**, by letter dated November 10, 2015, the Township Engineer, James M. Oris , P.E. has recommended to the Township Committee that said bids be rejected and the Township Committee authorize the re-bid of the project; and

**WHEREAS**, the Township Committee wishes to accept the recommendation of its consulting Engineer and agrees that the proposed bids far exceed the Township estimate for the work proposed. The Township Committee believes that a reduced price can be received if the matter is re-bid and more bidders participate; and

**NOW THEREFORE BE IT RESOLVED** this 12<sup>th</sup> day of November, 2015 by the Township Committee, Township of Ocean, County of Ocean and State of New Jersey as follows:

1. The Township of Ocean hereby rejects the bids received from J.H. Williams Enterprises and Cypreco Industries, Inc. for the proposed Barrier Free Access Improvements at the Municipal Complex.
2. The Township hereby authorizes the Township Engineer and Clerk to re-bid the project.
