**RESOLUTION FILLING A VACANCY IN THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF OCEAN, COUNTY OF OCEAN AND STATE OF NEW JERSEY**

**BE IT RESOLVED** by the TOWNSHIP COMMITTEE of the TOWNSHIP OF OCEAN, in the County of Ocean and State of New Jersey, as follows:

**WHEREAS**, a vacancy currently exists in the office of the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey; and

**WHEREAS**, the vacancy relates to a term of Committeeman Joseph Lachawiec who unexpectedly passed away on November 17, 2015; and

**WHEREAS**, Mr. Lachawiec's term expires on December 31, 2015 and in accordance with State Law, the political party who had nominated him for his position on the Township Committee, has submitted three names to the Township Committee for purposes of filling the unexpired term; and

**WHEREAS**, the Township Committee has reviewed the names submitted and has determined to appoint Daniel Collamer for the unexpired term of Mr. Lachawiec which term shall expire on December 31, 2015; and

**WHEREAS**, Mr. Collamer was recently elected in the November 3, 2015 general election and is scheduled to take office on January 1, 2016 as a result of his election.

**NOW, THEREFORE BE IT RESOLVED** this 10<sup>th</sup> day of December, 2015 by the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey as follows:

1. That Daniel Collamer be and is hereby appointed to fill the vacancy of Joseph Lachawiec on the Ocean Township Committee effective upon the adoption of this Resolution for the unexpired term until December 31, 2015..
