Committee Reports

Mayor - Tina Wetter

1. COFFEE WITH A COP

In a continuing effort to reach out to the community, Ocean Township Police will sponsor a "Coffee with a Cop" event to be held on Saturday, May 30, 2015, from 8am to noon at the Dunkin Donuts in the Shoprite Plaza on Route 9. The purpose of this program is to provide a casual and informal atmosphere where residents can meet Township police officers and ask questions or voice concerns along with getting a free cup of coffee, courtesy of the Township of Ocean Police Department.

With all of the negative news lately about law enforcement, it is important that we come out to support our local Police Department. 1. WARETOWN SPRING WINE FESTIVAL

The Waretown Spring Wine Festival will be held this coming weekend, April 25 and 26, from noon to 5pm each day at the Waretown Recreation and Lake area. Tickets purchased in advance are \$12 and will be \$15 at the gate. Designated drivers and those under "21" are admitted free to the event, but obviously cannot participate with sampling the products.

With an anticipated large crowd attending both days, offsite parking will be available at the Frederic A. Priff School. A free shuttle bus service will be available from the school to the lake for those parking off site. There will be limited handicap parking available at the Waretown Lake.

Committeeman Lachawiec inquired if there will be an award for the best tasting wine.

Deputy Mayor Tredy discussed commercial wineries from New Jersey will have wines for sale and tasting. There will be no awards given.

Jackie Petrosilli, Vessel Road, discussed there will also be crafters and food trucks there.

Committeeman – Joseph Lachawiec

Committeeman Lachawiec discussed looking into re-establishing the solar farm at the landfill on Wells Mills Road. Several things have happened since the Township stopped the process, due to the high cost of running the electric line from the landfill to Barnegat to Savannah Drive. Atlantic City Electric raised the price from \$3 or \$4 million to \$21.5 million. There is a shorter route to run the electric from the landfill to where the high-tension lines are near the Parkway. There is a space of about 2.1 miles where there are no electric poles.

If the various state departments gave the Township permission to run the line underground for 2.1 miles, it will probably cost \$1 million per mile. Also the cost of installing solar panels has dropped dramatically in the last three (3) years. In 2009, the cost was going to be \$40 million. Then consultants discussed \$30 million, with the Township possibly receiving an extra 5 million watts. That is when Atlantic City Electric raised the cost. If the Township could get the Pinelands Commission to approve running the underground line, it might cost \$2 or \$3 million. The cost of actually installing 25-30 megawatts of electric power on the landfill would drop around 50% -60%. The cost of installation and the actual cost of the panels has dropped dramatically.

Six Flags is willing to chop down hundreds of acres of trees, in order to install solar panels. The electric could be used for their own uses, saving on huge electric bills. The other issue is the SRECs (Solar Renewal Energy Certificates). The big deal three years ago was that the SRECs were going for \$6.15 per kilowatt. Contractors would make a lot of money on the SRECs. State costs have gone down dramatically to \$1-\$2.

The Township could save \$250,000 a year by installing a number of solar panels. It might only be 5-15 megawatts. That could be \$10 or \$12 million instead of \$30 million. This is information to think about and look at in the future.

Administrator Report

Administrator - David Breeden

Ordinance 2015-2 and 2015-3, First Reading. The Ocean County Prosecutor would like to set up a system in which items sold to secondhand stores, dealers, pawn shops or scrap dealers can be tracked in a timely manner. Individuals who engage in criminal activity associated with substance abuse often steal to finance their habit. The stolen items are taken to these businesses and sold. If law enforcement has timely access to items that are sold, the likelihood of the crime being solved drastically increases. The Ocean County Prosecutor is taking advantage of technology to track these items and solve the crime. The Ocean County Prosecutor has requested every municipality adopt this ordinance and institute the program.

Resolution 2015-151, appointing a new CFO as of May 1, 2015. The Township's longtime CFO, Christine Thorne, will be retiring. The Township wishes her well in her retirement. Cliff Keen is formally the Superintendent of the Water/Sewer Department and had expressed an interest in Finance. Cliff Keen was successful in completing all the courses and passed the state exam. The Township Committee wishes Cliff success in his new position.

Resolution 2015-152, authorizing the Township to participate in an electronic tax sale. Municipalities are responsible for collecting taxes for the Township, schools and county. In 2014, the Township had to budget \$450,000 in a reserve for unpaid taxes. To get that money back, the Township has to have a tax sale. The tax sale is labor intensive and uses a lot of staff hours to accomplish. There are also operational costs such as advertising. The electronic tax sale greatly reduces the cost and the amount of time the Tax Collector allocates to a tax sale. The Township also has to pay \$15 per line item. The Township will also save money not having to put a large advertisement into the newspaper, which costs thousands of dollars.

Committeeman Lachawiec discussed a tax lien sale is when the Township does not collect taxes from a property because the owner did not pay. People who want to invest will buy the tax lien and give the Township money. Committeeman Lachawiec inquired what happens next.

Township Administrator Breeden discussed the property owner either settles with the lienholder or eventually the lienholder will secure the property over a certain period of time.

Township Attorney McGuckin discussed the investor gets paid 18% interest.

Township Administrator Breeden discussed a foreclosure can be filed within 5 years.

Deputy Mayor Tredy discussed the initial holder continues to pay the taxes.

Township Administrator Breeden discussed the property owner has to settle up with the lienholder. It is a mechanism that allows the Township to continue receiving taxes, in order to make payment to the school and county.

Resolution 2015-154 through 2015-160, recognizing and acknowledging a totally disabled veteran. A veteran that qualifies for total disability is exempt from paying property taxes to the Township, school and county. On an annual basis, the Township will receive payment from the state for the taxes the disabled veteran is exempt from.

Resolution 2015-187 and 2015-188, hiring Summer Recreation Aides and Lifeguards. These seasonal employees are paid anywhere from \$8-\$20 per hour, depending on the job title and the number of years with the Township. The Lifeguards work both in the Township of Ocean and Barnegat.

Resolution 2015-191, awarding a fireworks contract to Pyrotechnics. The Township of Ocean, Barnegat, Ocean City and Sea Isle City formed a co-op, in order to go out to bid for Fireworks. This bid secured a competitive price for a two-year period.

Resolution 2015-195, awarding a contract in the amount of \$93,500 to install lightning protection equipment in the Township water/sewer infrastructure. When severe thunderstorms are moving through the area, the Township turns down or turns off the power of some of the water treatment plants. That is not a normal practice. The Township needs to protect its assets.

Resolution 2015-198 and 2015-199. State law requires each local government to provide certain services or reimburse services to certain private communities or condominiums. The services are usually snow plowing, street lighting, leaf collection, trash and recycling.

Jacquelyn Petrosilli, 11 Vessel Road, requested an explanation of Resolution 2015-194 for the temporary appropriation of \$628,000.

Township Administrator Breeden discussed at the beginning of the year on January 2, 2015, during the Reorganization meeting, the Township established a Temporary Budget, which is 26.75% of the previous year's budget. That carries the Township through the first three months. The Township is in its fourth month. In order to continue paying the bills, the Township has to increase the Temporary budget by approximately \$600,000. The Township will continue to increase the temporary budget until a permanent budget is adopted, which will probably be in June or July. The state has adopted a practice of not certifying state aid until the state budget is adopted on July 1st.

Committeeman Lachawiec inquired if there is a state law requiring the budget to be adopted by a certain date.

Township Attorney McGuckin discussed there is but the state does not certify the state aids. Municipalities cannot adopt a budget until it knows what the state aid is.
