

**RESOLUTION AUTHORIZING CHANGE ORDER NO. 1
BRYANT ROAD WATERFRONT IMPROVEMENTS
CONTRACT WITH K & G MARINE CONTRACTING**

WHEREAS, the Township of Ocean has previously entered into a Contract with K & G Marine Contracting for the project known as the Bryant Road Waterfront Improvement Project; and

WHEREAS, in accordance with the bids received and Contract awarded by the Township, the original Contract cost was \$458,387.00; and

WHEREAS, by letter dated December 29, 2015 the Township Engineer, James M. Oris, PE has recommended to the Township Committee that a Change Order be executed with respect to this Contract resulting in a reduction of the Contract amount to \$420,531.00 which sum represents an 8.26 % reduction in the overall Contract price; and

WHEREAS, this reduction is a result of as-built quantities for the project being less than originally contemplated; and

WHEREAS, the Township Committee wishes to accept the recommendation of its Consulting Engineer.

WHEREAS, the Township Engineer has further recommended that the Contract be "Closed out" upon execution of the Change Order referenced herein.

NOW THEREFORE BE IT RESOLVED this 14th day of January, 2016 by the Township Committee, Township of Ocean, County of Ocean and State of New Jersey as follows:

1. The Township of Ocean hereby authorizes Change Order No. 1, reducing the Contract amount from \$458,387.00 to \$420,531.00.
2. The Township Committee hereby authorizes the "Close-out" of the Contract
