

RESOLUTION 2016 - 117

**RESOLUTION AUTHORIZING THE RELEASE
OF PERFORMANCE GUARANTEE FOR
GREENBRIAR OCEANAIRE SECTION 8,
PHASES A & B, WATER SYSTEM IMPROVEMENTS**

WHEREAS, Lennar Corporation is currently developing an age-restricted residential community within the Township of Ocean known as Greenbriar Oceanaire; and

WHEREAS, in accordance with the approvals previously received for this Project, the applicant has posted certain Performance Guarantees for Section 8, Phases A & B, Water System Improvements, totaling \$329,829.48; and

WHEREAS, said the Performance Guarantee consists of Bond # K0793306A issued by Westchester Fire Insurance Company dated February 28, 2012 in the amount of \$296,846.53, and a Cash Bond in the amount of \$32,982.95; and

WHEREAS, by letter dated December 7, 2015 the Township's Engineer, James Oris, P.E. has advised the Township Committee that he has inspected the improvements subject to said Performance Guarantees and has determined that all improvements have been installed in substantial conformance with the approved Subdivision Plans and Planning Board Approvals; and

WHEREAS, the Township Engineer has recommended the Performance Guarantees be released; and

WHEREAS, the Township Committee wishes to accept the recommendation of its Consulting Engineer.

NOW, THEREFORE BE IT RESOLVED this 14th day of January, 2016 by the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey as follows:

1. The Township hereby authorizes release of Performance Guarantees Bond # K0793306A issued by Westchester Fire Insurance Company dated February 28, 2012 in the amount of \$296,846.53 and a Cash Bond in the amount of \$32,982.95 conditioned upon the applicant posting a Maintenance Guarantee with the Township in the amount of \$49,474.42, which Maintenance Guarantee shall run for a period of two (2) years.
