**RESOLUTION AUTHORIZING CHANGE ORDER NO. 2 s  
SKIPPERS COVE SANITARY SEWER REPLACEMENT  
CONTRACT WITH P&A CONSTRUCTION**

**WHEREAS**, the Township of Ocean has previously entered into a Contract with P&A Construction, Inc. for the sanitary sewer replacement project located within Skippers Cove Section of the Municipality; and

**WHEREAS**, by letter dated November 4, 2015 the Township Engineer, James M. Oris, P.E. has requested the Township Committee authorize Change Order No. 2 for said Contract; and

**WHEREAS**, the initial Contract was for an amount of \$3,246,191.98; and

**WHEREAS**, the Township Engineer is recommending an increase of that Contract by 0.586% to a total of \$3,253,993.89; and

**WHEREAS**, the Township Engineer advises that the purpose of the Change Order and increase in the Contract cost is due to the re-routing of residential sewer laterals, manhole modifications and removal of buried structures which were not contemplated in the bid proposal when the Contract was previously entered into; and

**WHEREAS**, the Township Engineer further advises that these costs, including this Change Order, are eligible for project funding through the NJEIT; and

**WHEREAS**, the Township Committee wishes to accept the recommendation of its consulting engineer.

**NOW THEREFORE BE IT RESOLVED** this 11th day of February, 2015 by the Township Committee, Township of Ocean, County of Ocean and State of New Jersey as follows:

1. The Township of Ocean hereby authorizes Change Order No. 2 for the Sanitary Sewer Contract between the Township of Ocean and P&A Construction with a Contract being amended to reflect a total cost of \$3,253,993.89.
