

ORDINANCE NO. 2016-2

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF OCEAN, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 268 OF THE TOWNSHIP OF OCEAN ENTITLED "PEACE AND GOOD ORDER"

BE IT ORDAINED by the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey as follows:

SECTION I. Chapter 268 of the Township Code, entitled "Peace and Good Order" is hereby amended and supplemented to include a new section to be designated as 268-16, which shall provide as follows:

PROHIBITION ON CASTING OF SNOW OR ICE.

No owner, tenant or occupant of any premises, whether residential, commercial, or non-profit, abutting any street or public roadway in the Township of Ocean, shall throw, place or deposit snow or ice into or on any such street or public roadway, it being the intent and purpose of this provision to prohibit all persons from throwing, casting, placing or depositing snow and ice which accumulates within the private property belonging to that person on streets located within the Township of Ocean. S

SECTION II. PENALTIES

Any person, including the owner, tenant or occupant of any premises actually casting the snow or ice onto a public roadway within the Township of Ocean in violation of the terms of this Chapter, shall, upon condition be subject to a fine of not more than \$500.00. Each instance in performing such action shall constitute a separate and distinct offense subject to any and all penalties described herein.

SECTION III. All Ordinances and parts of Ordinances inconsistent herewith are hereby repealed.

SECTION IV. If any Section, Sub-Section, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by a Court of competent jurisdiction, such portion shall be deemed a separate distinct and independent provision and such holding shall not affect the remaining portions.

SECTION V. This Ordinance shall take affect after second reading and publication as required by law.

NOTICE IS HEREBY GIVEN that the foregoing Ordinance was introduced and passed by the Township Committee of the Township of Ocean on first reading at a meeting held on the 22ND day of February, 2016. The Ordinance will be considered for second and final reading at a meeting of the Township Committee which is scheduled for the 10th day of March, 2016 at 7:30 p.m., or as soon thereafter as the matter may be reached, at the Municipal Building located at 50 Railroad Avenue, Waretown, New Jersey, at which time the public is invited to ask questions, raise objections, or provide public comment with regard to the proposed adoption of this Ordinance.
