

**RESOLUTION AUTHORIZING THE AWARD OF A
CONTRACT TO P&A CONSTRUCTION FOR THE PEBBLE
BEACH AREA WATER AND SEWER IMPROVEMENTS**

WHEREAS, the Township of Ocean, County of Ocean, State of New Jersey has previously advertized for and received bids on Wednesday, April 6, 2016 for a project known as the Pebble Beach Area Water and Sewer Improvements; and

WHEREAS, the bid specifications provided for separate base bids for the sanitary sewer and potable water work and a total combined base bid; and

WHEREAS, the following bids were received:

WHEREAS, it appears that P&A Construction, Inc. is the lowest responsible bidder for this project; and

WHEREAS, the Township Committee wishes to accept the recommendation of its consulting engineer; and

NOW THEREFORE BE IT RESOLVED this 14th day of April, 2016 by the Township Committee, Township of Ocean, County of Ocean and State of New Jersey as follows:

1. The Township hereby awards a contract to P&A Construction, Inc. of Colonia, New Jersey for the Pebble Beach Area Water and Sewer Improvement Project in accordance with the bid specifications and Contract to be executed by the Contractor.
