

RESOLUTION NO. 2016-277

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF OCEAN, COUNTY OF OCEAN, STATE OF NEW JERSEY, EXTENDING THE EXISTING CONTRACT WITH WASTE MANAGEMENT, INC. FOR SOLID WASTE COLLECTION UNTIL NEW BIDS ARE RECEIVED FOR A NEW CONTRACT.

WHEREAS, the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") previously entered into an agreement for solid waste pick up, after competitive bidding, with Waste Management, Inc.; and

WHEREAS, a prior bid was awarded in accordance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1, *et seq.*; and

WHEREAS, the Township is in the process of preparing new bid specifications in order to solicit new bids for a new joint contract for solid waste collection; and

WHEREAS, an existing contract with Waste Management, Inc. expires on or about June 30, 2016, and therefore needs to be extended on a month-by-month basis until the new contract is awarded.

NOW, THEREFORE, BE IT RESOLVED, this 9th day of June, 2016, by the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey, as follows:

1. The Township hereby extends the existing contract for solid waste pick up with Waste Management, Inc. on a month-by-month basis, under the same terms and conditions as exist in the contract.
2. The Township authorizes and directs the Mayor and Township Clerk to execute any and all necessary documents in order to implement the intent of this Resolution.
