

**RESOLUTION AUTHORIZING THE AWARD OF A  
CONTRACT TO THE RODGERS GROUP, LLC FOR  
POLICE ACCREDITATION CONSULTING SERVICES**

**WHEREAS**, the Township of Ocean, County of Ocean, State of New Jersey is in need of the services of a consultant to assist in securing accreditation for the Ocean Township Police Department; and

**WHEREAS**, the Township's Insurance Carrier, Ocean County Joint Insurance Fund, provides grants of up to \$20,000.00 to assist Municipalities for members of the Ocean County JIF to obtain such accreditation consultants; and

**WHEREAS**, the Township of Ocean has applied to the Ocean County JIF for such a grant; and

**WHEREAS**, the Township has reviewed the credentials of The Rodgers Group, LLC to provide consulting services to the Municipality in order to secure accreditation for the Ocean Township Police Department' and

**WHEREAS**, conditioned upon receipt of a grant from the Ocean County Joint Insurance Fund, the Township Committee wishes to enter into a Contract with The Rodgers Group, LLC for the total sum of \$39,900.00.

**NOW THEREFORE BE IT RESOLVED** this 14th day of July, 2016 by the Township Committee, Township of Ocean, County of Ocean and State of New Jersey as follows:

1. The Township hereby authorizes the Mayor and Township Clerk to execute a Contract with The Rodgers Group, LLC for a total sum of \$39,900.00 conditioned upon the Township receiving a grant from the Ocean County Joint Insurance Fund in the amount of \$20,000.00.
