

RESOLUTION 2016 -365

RESOLUTION AWARDING A BID FOR CURBSIDE RECYCLING COLLECTION IN THE TOWNSHIP OF OCEAN FOR A PERIOD OF FIVE YEARS TO MEADOWBROOK INDUSTRIES

WHEREAS, the Township of Ocean has previously advertised for and received bids for the provision of curbside recycling collection within the municipality; and

WHEREAS, the lowest bid for these services has been provided by Meadowbrook Carting for a total sum of \$568,146.84; and

WHEREAS, in addition to being the lowest bid received, Meadowbrook Carting appears to be the lowest responsive bidder for these services; and

WHEREAS, the Township of Ocean wishes to authorize the award of a contract to Meadowbrook Carting in accordance with the bid specifications and bid received for this project; and

WHEREAS, the annual contract amount shall be as follows:

Year One	\$111,232.44
Year Two	\$113,105.04
Year Three	\$114,603.12
Year Four	\$114,603.12
Year Five	<u>\$114,603.12</u>
Total:	\$568,146.84

WHEREAS, the Township has determined that the awarding of a five (5) year contract is the most advantageous for the municipality and provides the lowest cost for its residents.

NOW, THEREFORE BE IT RESOLVED this 28th day of September, 2016 by the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey as follows:

1. The Township hereby awards a contract to Meadowbrook Industries for the provision of curbside recycling collection in accordance with the bid received and bid specifications previously advertised by the municipality for a total contract price of \$568,146.84 for the period commencing October 1, 2016 through September 30, 2021.
