

RESOLUTION 2016 - 387

RESOLUTION AUTHORIZING CHANGE ORDER NO. 4 FOR THE SKIPPERS COVE, SENECA BOULEVARD, 11TH STREET WATER SEWER MAIN REPLACEMENT, POTABLE WATER CONTRACT

WHEREAS, the Township of Ocean has previously entered into a contract with P&A Construction for the project known as the "Skippers Cove, Seneca Boulevard and 11th Street Water and Sewer Main Replacement"; and

WHEREAS, the contract with respect to the potable water system has been previously adjusted to reflect a contract amount of \$1,734,945.90; and

WHEREAS, pursuant to correspondence of Township Engineer, James M. Oris, P.E., dated October 7, 2016, the Township Engineer has recommended the issuance of Change Order No. 4 for the potable water contract with P&A Construction, which Change Order would authorize a reduction in the contract to reflect a total sum of \$1,710,336.55; and

WHEREAS, this reduction would represent an overall decrease of 1.44% from the original contract amount; and

WHEREAS, the Township Engineer has advised that due to field conditions it is appropriate to adjust the contract as noted herein.

NOW, THEREFORE BE IT RESOLVED this 13th day of October, 2016 by the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey as follows:

- 1.) The Township hereby authorizes Change Order No. 4 for the potable water contract with P&A Construction, which will result in an adjusted contract amount reduction from \$1,734,945.90 to \$1,710,336.55.
