

RESOLUTION 2016 – 388

RESOLUTION AUTHORIZING CHANGE ORDER NO. 4 FOR THE SKIPPERS COVE, SENECA BOULEVARD, 11TH STREET WATER SEWER MAIN REPLACEMENT, SANITARY SEWER CONTRACT

WHEREAS, the Township of Ocean has previously entered into a contract with P&A Construction for the project known as the “Skippers Cove, Seneca Boulevard and 11th Street Water and Sewer Main Replacement”, i.e., sanitary sewer contract; and

WHEREAS, the previously adjusted contract amount is \$3,258,731.37; and

WHEREAS, by letter dated October 7, 2016 the Township Engineer, James M. Oris, P.E., has recommended to the Township Committee that Change Order No. 4 be issued for the sanitary sewer contract which will result in an overall increase in the contract amount to \$3,321,215.32; and

WHEREAS, this sum represents an overall increase of 2.66 percent from the original contract amount; and

WHEREAS, the basis for this increase is unforeseen field conditions at several locations within the project area requiring existing infrastructure repair; and

WHEREAS, the Township Committee wishes to accept the recommendation of its Consulting Engineer.

NOW, THEREFORE BE IT RESOLVED this 13th day of October, 2016 by the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey as follows:

- 1.) The Township hereby authorizes Change Order No. 4 for its sanitary sewer contract with P&A Construction for the Skippers Cove, Seneca Boulevard and 11th Street water and sewer main replacement project within the Municipality, which Change Order shall result in the increase of the contract from \$3,258,731.37 to \$3,321,215.32.
