

ORDINANCE NO. 2016-13

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF OCEAN, COUNTY OF OCEAN, STATE OF NEW JERSEY, RE-ESTABLISHING THE FEES FOR THE RENTAL OF THE TOWNSHIP'S WARETOWN LAKE PAVILION AND COMMUNITY CENTER

BE IT ORDAINED by the Township Committee of the Township of Ocean, County of Ocean, State of New Jersey as follows:

SECTION I. The Township has reviewed the Fees charged for use of the Township's Community Center and Waretown Lake Pavilion and has determined that it is appropriate to provide new Fees for such rentals.

SECTION II. The following Fees shall apply for the rental of the Ocean Township Community Center and for the Waretown Lake Pavilion, as follows:

2017 - Minimum Fee - \$100.00 for five (5) hours, one (1) hour set up and clean up. Any additional hours shall be \$20.00 per hour.

2018 - Minimum Fee - \$150.00 for five (5) hours, one (1) hour set up and clean up. Any additional hours shall be \$20.00 per hour.

2019 - Minimum Fee, and until further Ordinance Amendment - \$200.00 for five (5) hours, one (1) hour set up and clean up. Any additional hours shall be \$20.00 per hour.

SECTION III. A non-profit organization is not required to pay the Fee to rent, however, they are required to provide all insurance coverage.

SECTION IV. All other Ordinances with respect to the regulations and use of the Community Center or Waretown Lake Pavilion area shall remain in full force and effect.

SECTION V. Any section, subsection, clause, phrase, ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION VI. This Ordinance shall take affect after second reading and publication as required by law.

NOTICE IS HEREBY GIVEN that the foregoing Ordinance was introduced and passed by the Township Committee of the Township of Ocean on first reading at a meeting held on the 10th day of November, 2016. The Ordinance will be considered for second and final reading at a meeting of the Township Committee which is scheduled for the 8th day of December, 2016, at 6:30 p.m., or as soon thereafter as the matter may be reached, at the Municipal Building located at 50 Railroad Avenue, Waretown, New Jersey, at which time the public is invited to ask questions, raise objections, or provide public comment with regard to the proposed adoption of this Ordinance.
