### <u>Proclamation</u> National Library Week 2017

Mayor Wetter presented a proclamation to Melissa Rutkowski, proclaiming April 9-15, 2017 as National Library Week in the Township of Ocean. Mayor Wetter read the proclamation.

Ms. Rutkowski invited residents to visit the Waretown Branch Library. The library can use your support now, more than ever.

Deputy Mayor Collamer discussed the Ocean Township School District Librarian, Mrs. Learning, is present tonight and should be recognized.

Township Attorney McGuckin discussed the Waretown Public Library was a nonprofit corporation run by local Waretown residents for many years. In the 1990's, when the County library system had expanded and the Board of Trustees, who are made up of local residents, decided it would be in the best interest of the Township to donate this library to the Ocean County library system to provide better service and better hours. There is a deed of reversion, if the County should ever close that library, that land reverts back to Ocean Township.

Deputy Mayor Collamer discussed the library was originally funded through money from the estate of Dorothy Reeves.

### **Committee Reports**

#### Mayor – Tina Wetter

Resolution 2016-165 amends the Shared Service Agreement regarding the Ocean County Prosecutor's Office for DWI enforcement. The reimbursement for an officer was \$50.00 per hour. It is being amended to \$70.00 per hour.

Resolution 2017-168 authorizes the purchase of self-contained breathing apparatus (SCBA) packs for the Waretown Volunteer Fire Department. These are required by OSHA. The Fire Department's air packs expire this month. It is imperative to make sure the volunteers have the equipment they need to perform their duties. This will assist in keeping the volunteers safe, as required by OSHA, and allow them to continue serving the Township residents. The Township Committee appreciates all their volunteers and emergency services.

### **Deputy Mayor – Dan Collamer**

Ordinances 2017-3, 2017-4, 2017-5 and Resolutions 2017-156, 2017-157, 2017-158, 2017-159, 2017-160 solidify the Township's position with Fair Share Housing, a part of the affordable housing COAH agreement, which protects the Township from Builders Remedy, which forces the Township to build affordable units anywhere in the Township, which the town does not want built.

Resolution 2017-161 is a resolution for the Redevelopment Committee to deny a request for two storage facility buildings on Route 9 just south of Pancoast Road. The use was not zoned for the site and the Redevelopment Committee, after hearing the application, chose to deny that application.

Brent Cunningham, Chief, Waretown Volunteer Fire Company #1, discussed in 2016 the Fire Department responded to 197 emergency calls. This resulted in 2,400 man hours of service. Additionally, as the year goes on, the Fire Department spends time each week, every week of the year, perfecting training, providing upkeep to the building and equipment, and discussing and planning for future services. This resulted in an additional 2,500 man hours of service. The Fire Department happily performs these tasks, vigorously and with a strong sense of pride, while preparing the next generation for the same rewarding service.

None of this would be feasible without the continued support of the Township and the Township Committee. The air packs do indeed bring the Fire Department up to OSHA federal regulations and allow the Fire Department to maintain its safety and the safety of incidents and scenes and the safety of every single resident of this Township and surrounding Townships. Thank you for giving the Fire Department the opportunity to present this information and thank you for your continued support.

Mayor Wetter thanked the Waretown Volunteer Fire Company.

John Petrosilli, 11 Vessel Road, inquired if Ordinance 2017-6 will precipitate increasing the tax rate to fund revenue and will there be enough money in the existing tax rate to cover the increase.

Township Administrator/Clerk Ambrosio discussed it is a budgeting tool the Township can use to create a surplus, if necessary. The CAP bank opens the levy CAP. This ordinance is completed every year. It is covered in this year's budget.
