## Notice of Water Service Line Material Confirmation

Dear Resident:

In July 2021, P.L.2021, Ch.183 (Law) was enacted, requiring all community water systems to replace lead and galvanized service lines in their service area within 10 years. Under the law, the Township of Ocean is required to inventory public and private water services to identify all service line materials. The Township's water service line inventory is available at <https://twpoceannj.gov/index.html>. The current service line inventory identifies this address as an **unknown material** for the "PRIVATE WATER SERVICE" as identified in the image below.


