1. Minimum Fee- \$20 per day, or \$100 per week. Each mobile food vendor unit shall be permitted separately.
2. Upon renewal, the applicant shall pay the renewal of \$150 and update any changes in the permitting documentation upon permit renewal. The applicant must submit the application 30 days before expiration of the permit or must reapply as a new applicant.

Food trucks must display ALL permits on truck.
